Professional Background

And when impassible issues arise, Maranda represents tribal and non-tribal clients in litigation in state, federal and tribal courts, as well as alternative dispute resolution.

Prior to joining Van Ness Feldman, Maranda worked for a large international law firm in their Denver, Colorado office. Maranda also served as a law clerk to Justice Allison H. Eid of the Supreme Court of Colorado (now of the U.S. Court of Appeals for the Tenth Circuit) and clerked for the Native American Rights Fund while in law school.
