**Professional Background**

As a former Trial Attorney in the Environmental Enforcement Section of the United States Department of Justice (DOJ), Kaki has extensive experience litigating cases under the nation's major environmental laws, and she is well-connected to many DOJ and Environmental Protection Agency (EPA) current and former lawyers. Hired under the prestigious and highly competitive Attorney General's Honors Program, Kaki represented EPA for nearly a decade in numerous complex civil actions arising under federal environmental statutes. She has negotiated multi-million-dollar consent decrees and litigated cases when settlements were not achievable. With her extensive experience as lead counsel in major environmental cases, combined with her scientific background, Kaki brings a wealth of experience and energy to her environmental practice.

Kaki also managed her own law practice as an estate planning attorney. For a decade, she counseled families on their estate planning needs, providing guided, focused discussions to understand their objectives and then drafting highly customized documents that executed clients' specific intentions.

For more than twenty years she has been actively engaged in advocacy on numerous issues in her community that concern her the most-- environmental protection, food/nutrition issues, voter protection and youth sports safety.
