# **Professional Background**

During his final year at the George Washington University Law School, Paul clerked for the Vehicle and Engine Enforcement Branch of the EPA's Office of Enforcement and Compliance Assurance, where he worked on enforcement actions involving aftermarket defeat devices, proceedings before the Environmental Appeals Board, and self-disclosure matters.
