**Professional Background**

Brent provides strategic advice and critical support to clients with large complex land-based and in-water development projects. He has in-depth knowledge of local, state, and federal land use and environmental regulations, and has successfully navigated clients through local rezones comprehensive plan amendments, master plans, shoreline permits, and development agreements; state 401 water quality certifications and NPDES permits, U.S. Army Corps of Engineer Section 10, 404 and 408 permits, and ESA consultations. Brent's litigation practice before local and state administrative tribunals, and in state and federal court, includes defense of development approvals and response to environmental enforcement actions.

Prior to his law practice, Brent worked for the Puget Sound Clean Air Agency in Washington State, where he helped create one of the nation's first air pollution mitigation banking programs.

**Representative Experience**

- Represents the Port of Kalama, co-applicant with Northwest Innovation Works, in the development of a methanol manufacturing plant, new dock and marine transfer facility, and other associated process elements including a Ranney well proposed on port property. Work includes overseeing the environmental review and all aspects of federal, state and local air, water and land use permitting including Section 10 and 404 permits, and Endangered Species Act and NEPA compliance, State Environmental Policy Act (SEPA), Environmental Impact Statement (EIS), local air permits and shoreline permits for the new dock and the methanol processing facility. A partner pipeline company will be building a lateral pipeline extension that will bring natural gas from the existing natural gas transmission line to the new facility for methanol production, loading and transport to China for use as a feedstock in plastics production.
- Represents Vancouver Energy, a joint Venture between Tesoro Refining and Marketing Company LLC and Savage Companies overseeing all aspects of the company's proposed crude oil terminal and marine transfer facility at the Port of Vancouver, WA. The firm is managing a team of experts to obtain all federal and state industrial facility, land use, and environmental permits. The project has the potential to become one of the first "crude-by-rail" terminal expansion projects in the Pacific Northwest designed to help deliver North American Mid-continent crude oil to West Coast refineries.
- Secured and defended land use entitlements for numerous commercial, residential, institutional and resource projects, including 2+ million square foot regional shopping center, stores for national retailers, 800+ unit master planned community, hospitals, and colleges.
- Obtained high profile Section 404 and 401 permits for one of largest wetland fills and mitigation projects in Washington and successfully defended all permits in state and federal court.
