Professional Background

Before working in-house, Mosby practiced law at an international law firm where he represented a range of stakeholders in the energy markets including electric utilities, interstate pipelines, and financial institutions. He began his energy regulatory and transactional career as an Attorney-Advisor at the Federal Energy Regulatory Commission (FERC), where he specialized in electricity markets, rates, and tariffs.

Mosby is based in Houston and immersed in the region's emerging energy transition ecosystem. He is also the Immediate Past President of the Energy Bar Association and has served on the Board of Charitable Foundation of the Energy Bar Association, the Board of the Foundation of the Energy Law Journal, and the Steering Committee for the EBA's Energy Insecurity Initiative.

- Deputy General Counsel and Vice President at Kinder Morgan, serving as general counsel for Kinder Morgan's interstate natural gas pipelines, working closely with a team of exceptional in-house attorneys, commercial leads, operations personnel, business development units, and corporate executives.
