Professional Background

At Van Ness Feldman, she serves as a strategic advisor to corporate legal departments, helping assess regulatory risks and develop compliance frameworks for major infrastructure projects. Tiffanie regularly translates complex regulatory requirements into actionable business guidance, developing corporate training programs, and establishing compliance procedures for commercial operations.
