**Professional Background**

Prior to his government service, Joe worked as a trial attorney, litigating a broad range of complex civil and criminal matters in both state and federal courts.

- Advised the Office of Pipeline Safety in the development of FAQs related to the above Final Rules.
- Advised the Office of Pipeline Safety on updates to the MOU between the Department of Transportation (DOT) and the Department of Interior (DOI) re: outer continental shelf pipelines and provided counsel on the implementation of other federal MOUs regarding coordination between agencies responsible for the regulation of pipeline and LNG facilities.
- Provided legal counsel to the agency in responding to, and closing out, Congressional mandates, National Transportation Safety Board recommendations, and GAO reports.

safety laws.
