**Professional Background**

Shannon Angielski is uniquely skilled at engaging with federal policymakers, state and local agencies, key stakeholders, and non-governmental entities to find solutions that allow progress for the energy industry.

Shannon is a leader in our [Energy Transition](#) practice where she develops and advocates for clean energy, carbon management policies, and federal funding for projects. She has a particular focus on the decarbonization of hydrogen, recognizing early on its significance to the success of the energy transition and potential to cut across multiple industries. She has worked to raise awareness and build support among key stakeholders, including founding and leading the [Clean Hydrogen Future Coalition](#).

Shannon also has a wealth of experience working on carbon capture, utilization, and sequestration ("CCUS") policies. Her clients include members of the electric power and industrial sectors, equipment manufacturers, technology developers, trade associations and labor unions, on whose behalf she develops, implements, and manages advocacy strategies. Shannon's efforts have frequently resulted in the successful enactment of key legislation and federal funding. Examples include the Section 45Q carbon sequestration tax credits, the new Section 45V hydrogen production tax credit that was included in the Inflation Reduction Act, the Infrastructure Investment and Jobs Act (IIJA) clean hydrogen hubs provision, and the IIJA CCS programs.

Shannon serves as the Executive Director of the [Carbon Utilization Research Council \(CURC\)](#) and as the President of the [Clean Hydrogen Future Coalition](#). In these leadership roles, Shannon develops and supports the coalitions' federal policy initiatives and advocates for their goals. She also serves as the coalitions' spokesperson before federal policymakers and the media.

Shannon is a co-coordinator of the firm's Government Advocacy and Public Policy practice and leads the firm's Federal Funding and Grant practices.

**Representative Experience**

- Most recently launched a coalition focused on advancing policies to scale the full value chain for "clean" hydrogen, comprised of organizations that reflect the diversity of the value chain.
- Through representation of CURC, Shannon worked with the lead Congressional policymakers in the design and funding authorizations that were included in the Carbon Management Title and that were negotiated in the final conference agreement of the Energy Policy Act of 2020.
- Shannon led CURC's participation in the design and advocacy of billions in tax credits including the 2018 enactment of the landmark FUTURE Act to expand and revise the Section 45Q carbon sequestration tax credits, and strategically advances millions in annual appropriations for CCS research and development funding.
- Led an initiative through CURC to provide joint, consensus comments between industry and environmental NGOS to the Internal Revenue Service (IRS) on proposed regulations for issuing CCS tax credits under Section 45Q.
- Advises clients in successfully obtaining federal grants for advanced energy technology projects ranging from \$25 million to \$334 million, and in creating grant programs through agency-led solicitations, Congressional appropriations, and member-directed spending.

- As coordinator of the firm's federal funding practice, coordinated the development of a new firm model for clients to partner with the federal government, and represent clients under this new model in their efforts to secure federal funding for the development and deployment of new energy technologies.
